As a result of the budget process that the state of Ohio undergoes every two years, I have some exciting news to share with you. Like many states across the country, our state legislators have understood the importance of allowing families to make educational choices for their children. Ohio has joined states like Arizona, Arkansas, Florida, Indiana, and West Virginia, who allow educational decisions to be made at the most local level, the kitchen table.

If you make less than 450% of the Federal Poverty guideline, or approximately 135,000 per year for a family of four, your family is eligible to receive the full scholarship amount of \$6,165 for grades K-8 or \$8,407 for grades 9-12. If your family makes more than 450%, you are eligible for a percentage of the full scholarship amount, so that all Ohio families, if they apply, will receive a scholarship.
